## Re-TENDER DOCUMENT

1. **Eligibility requirements:**

- a. The bidder should be registered as a Service provider as per existing norms and Trade License in line with their credentials in support of being service provider.
- b. The bidder should have credential/experience in similar nature of work executed under Govt. sectors, PSUs, Govt. undertaking Sectors and Reputed Private Sectors.
- c. The bidder should possess Service Tax registration Certificate & valid PAN Card.

The bidder must attach the self attested copy of the following documents (as applicable) with the tender/quotation; otherwise the bid will be rejected out rightly

- i. Authorization from manufacturer against this Tender valid;
- ii. Approval/Registration as Supplier (if any);
- iii. Proof of Credentials criteria;
- iv. CST/VAT/TIN Registration Certificates;
- v. PAN Card.

2. **Value of the Tender :** Rs. 20,00,000/- (Rupees Twenty Lakh Only)

3. **Earnest Money Deposit:**

The bid must be accompanied with Earnest Money Deposit of Rs. 40,000/- (Rupees Forty Thousand Only) in the form of Demand Draft of any nationalized bank and in favour of The Principal, K. B. College, Bermo, payable at Kathara. Failing which, the tender will be rejected without consideration.

4. **Last Date of submission of tender:**

Re-Tender should be submitted on or before 24.05.2016 by 01.00 PM. Bids received after the scheduled date and time shall not be considered under any circumstances.

5. **Opening and Evaluation of tender:**

The tender will be opened on 24.04.2016 at 02:00 PM in the Principal Chamber, K. B. College, Bermo. The tenderer is at liberty to attend either himself or through their authorized representative at the opening of the tender. The representative attending the opening of the tender on behalf of the tenderer should bring with him a letter of authority from the tenderer and a proof of identification.

Board of Governors constituted by the Principal will evaluate the bids. The evaluation of the tenders will be done on the basis of fulfilment of eligibility conditions and on the basis of information furnished and the quoted price.

Technical Bid will be open, if the EMD along with tender cost (in case of downloaded from website) is found in order. The Financial Bid of only those bidders will be opened whose Technical bid is accepted by the Committee. Those, who will qualify in Bid evaluation, shall be intimated.

6. **Right of Acceptance:**

The Principal K. B. College, Bermo does not bind himself to accept the lowest quotation and reserves the right to reject any or all the tenders without assigning any reason thereof. The decision of the Principal in this regard will be final. Successful bidder will be informed the acceptance accordingly.

7. **Payment :**

The payment will be made only after delivery of items as per order and specification. No advance payment will be made at any cost.

8. **Preparation and Submission of Tender**

All the mandatory documents and each page of the bid must bear signature and seal of the bidder. The bidder should fill up the price schedule in clear and legible terms, without any overwriting or use of white fluid. The prices quoted should be written both in figures as well as in words. The Bids shall be submitted in three separate sealed envelopes as under:-

- a. Envelope A :- It Should contains the Demand Draft of EMD & Receipt/ Bank Draft of Document Cost and super scribed as "ENVELOP – A" with seal & signature of the bidder.
- b. Envelope B :- It Should contain the Technical Bid (FORM – I) and all necessary supporting documents and super scribed as "ENVELOP – B" with seal & signature of the bidder.
- c. Envelope C :- It Should contain the Financial Bid (FORM – II) and super scribed as "ENVELOP – C" with seal & signature of the bidder.

All the three envelopes should be inserted in a single envelope and duly sealed, addressed to Principal, K. B. College, Bermo, Bokaro, Jharkhand – 829113 and super scribed "Ref.
